Greetings Everyone, I am Roger B, Chair of PBC Intergroup.

The Intergroup store continues to operate. The store is very small, so we have a rule of 2 customers at a time and request that everyone have the courtesy to keep 6 feet apart wherever possible and to please wear a mask to protect yourself and others. Our Office Manager and Volunteers do the same. This has been an unusual year for Palm Beach County Intergroup and AA as a whole. We decided to try the in-person meeting in September and that worked out well, so we decided to do it again with this meeting and will continue to do so for the near future as long as the large room is available. The Advisory Committee met on August 31st. The report from that meeting will be presented during the Secretary's report. I had held off reporting on that meeting because it contained personnel information regarding the Office Manager that I had yet to discuss with her. I have discussed the annual evaluation with the Office Manager during the past month and while it was an excellent evaluation, the Advisory Committee had to make a decision that an increase in salary was not possible this year due to the unstable finances that were a result from the Covid-19 event. The Advisory Committee further stated that should finances go in a more positive direction, the lack of an annual salary increase could be offset by a holiday bonus. At this time, the finances have improved. We will continue to monitor this, and the Advisory Committee will talk at the beginning of December and make a recommendation on any possible bonus.

For the first time in my memory of being involved in Intergroup, this fiscal year's IRS tax filing was completed prior to the deadline without an extension needing to be filed. While I would like to take credit for that, I cannot. The conversion of Intergroup finances to QuickBooks along with the Institutions finances subsequently being converted to QuickBooks makes it very easy for our CPA to gather all the information and complete the filing. Of course, I cannot leave out the efficient work that our Office Manager does keeping the software up to date daily as well as her collaboration with the CPA with oversight by the Treasurer. A job well done by all involved.

Area 15 is making tentative plans for an in person quarterly assembly in Sarasota for the weekend of January 15th thru 17th, 2021. More details to follow.

We will be resuming elections this evening for Alternate Chair and a few Committee Chair and Liaison positions.

I am asking the Group Reps to go back to their Groups and ask them if they are interested in participating in some sort of modified Alcothon for Christmas and New Years. While it would not be the same as previous years as we don't want to get into serving coffee and sharing snacks, we feel it may be possible to loosely organize some sort of "safe space" where someone could come by and at least have another Alcoholic to fellowship with. We are also starting a conversation with the Triangle Club on the availability of their property if we do decide to have an event. We know that the Groups have gone through a lot of changes this year as far as meeting in person and meeting virtually. Some Groups have

just dissolved. So, at this time, we just want to get some feedback from the Groups. Group Reps can call or email the Intergroup Office during the next month with their feedback.
