Intergroup Meeting December 8, 2010
Call to Order: 6:17 PM Serenity Prayer Read 12 Traditions

Declaration of Unity: This we owe A.A.'s future: To place our common welfare first; to keep our fellowship united. For on A.A. unity depend our lives; and the lives of those to come.

Chairperson's Report: Alex A.: Since the last Intergroup Business Meeting: PBC Intergroup and District 8 hosted a Concepts Workshop which was lead by Past Delegate **Beth D.** and PBC. On November 21st, Bridging the Gap Chair Ashley N. and myself attended a special forum meeting with South County Intergroup and local Treatment Facilities. The purpose of this forum was to open a channel of communication between local A.A. Groups and the treatment facilities that bring their clients to meetings. A large part of the meeting focused on the AA 7th Tradition and the burden some groups experience when the Treatment Facilities bring large groups to meetings. The general concern was if the ratio of newcomers was greater than those with some experience in recovery, then the newcomer would suffer. Please keep your reports brief as we have three motions on the Agenda. Please address all comments to the Chair and remember, while we do encourage everyone to share, remember to limit yourself to 3 minutes and do not share your position if it has already been shared. Please refrain from the use of profanity and discourteous language while sharing.

Welcome New Representatives: Chris/Look to this Day, Frank/Noon Hour Group, Bruce/Good Guys Group, Erin/Gratitude Group, Angie/A Vision for Recovery, Christian/ Alt. A Vision for Recovery & Christopher/ Primary Purpose.

Vice Chair's Report: Steve Y.: Tickets for sale for the Unity Breakfast, Saturday January 29th @ Finland House. \$8. Working on the format for the Alcahons.

Treasurer's Report: Henry M.: Our total revenue for November 2010 was \$7,480.99 with expenses being \$7,111.96 leaving with a surplus of \$369.03. Our Checking account balance was \$4,435.48. We made a \$200.00 transfer into the Prudent Reserve account bringing that balance up to \$7541.21, which is below the \$22,000.00 mark by \$14,458.79. Our First Annual Bake Sale/ Open House netted \$165.97 but more importantly, it was a great day for fellowship. Our revenue in November 2009 was \$10,140.41 (\$1840.00 of which was contributed by friends of Intergroup from the proceeds of a benefit comedy show) with expenses being \$7,897.15 resulting in a surplus of \$2,243.26. Or checking account balance was \$5,325.31 and our Prudent Reserve balance was \$5,295.39 at that time. I must mention that higher revenues through contributions during the end of calendar year 2009 were due to concerns about our poor financial status at that time. With the spirit of service and prudence we are overcoming the obstacles which we were facing in late 2009 and early 2010. We are currently on the right track even though the previous year's figures would seem to say that we aren't. Fiscally we are actually showing a surplus of \$6,163.10. We are also showing an annual surplus of \$4,962.49 for the calendar year 2010. These surpluses are the result of lower office expenses, an attitude of service, and the continued support of the AA Groups we serve.

Secretary's Report: Karen L.: Accepted as posted in the Today.

Office Manager's Report: Ed B.: We currently have a full staff of Office Volunteers; however we could always use back-up volunteers during the holidays. If you're interested please call the Office at 655-5700. The total office activity for November was 437 compared to 616 last year which is a decline of 179. Most of the decline was in the following areas: calls for meeting information & emails. The website visits for November were 2,391. The number of first time visitors was 1,926 and the return visitors were 465. We have received many calls from individuals interested in the website meeting lists, a sign of its growing popularity. The Intergroup Office hours are Monday to Friday 9 - 5, and Saturday 9:30 - 1:30. We have many new items in inventory, which you might consider as holiday gift items. So stop by and have a look.

General Service/ Intergroup Liaison: Larry M.: The elections were finished.

South County Intergroup Liaison: Gary B.: South County Intergroup held its monthly business meeting on November 24, 2010 at Delray Central House. 2 Alcahons will be held this year. The one December 24th through December 25th and the other December 31st through January 1st. Meetings will be held on the even numbered hour followed by an hour of food and fellowship. The South County Intergroup Office will be closed December 25, 25, 31 NS January 1st however the hotline will be open to serve the alcoholic in need. The Office Manager, Pam T., attended the AAWWS/AAAGV annual seminar. The Gratitude Committee reported that the event raised \$11,370 and was enjoyed by the 400 people who attended. A motion was made and did not pass for Intergroup to conduct a Group Inventory during the 1st Quarter of 2011. There will not be a meeting of South County Intergroup in December and the next meeting will be held on the last Wednesday in January 2011.

We were reminded that AA is to be always inclusive not exclusive.

If you are in a correctional/treatment facility, give us a call.

Getting back into “real world” is not always easy for the alcoholic. Many of us had not been sober on the outside for a long time, and we admitted that the first days out were a little frightening. Sometimes, we did not know if we would stay sober. Even new members of A.A. usually know that they cannot make it alone. The dilemma for some of us was that we were not sure we could make it in A.A. either. We said things like, “where will I find a meeting I can be comfortable in?” or “Who will be able to trust?” It was tempting to give in to “I won’t fit in”, or “I’m too different.” Lots of alcoholics think like this; **we did.**

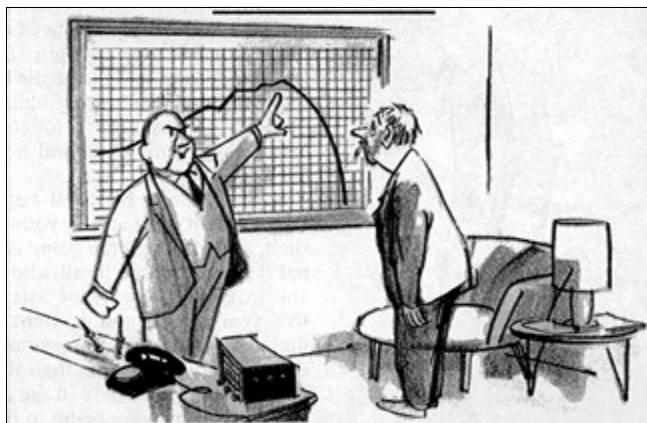
To begin contact and request help from A.A. volunteers, call the following number. You will be put in touch with the Bridging the Gap coordinator and a volunteer will contact you.
